5. That as a proximate result of the negligence of the Defendant, the Decedent, Laurie M Neu,

tragically lost her life leaving her minor daughter Lacie Neu.

6. A Proposed Complaint for Damages was previously filed against Dr. Kevin Forrest, Dr.

Stephen Pfeifer, and Dr. Roger Spahr. Discovery will need to be conducted to determine the

relationship between the Defendants in both actions and their involvement in the false and

misleading nature of the treatment plan and ultimate death of Laurie Neu.
