The Chairman announced the Panel's determination as

follows:

"Dr Myhill:

When the Interim Orders Panel first considered your case on 29 April 2010 it determined that it was necessary for the protection of members of the public and in the public interest, to impose an interim order of conditions on your registration for a period of 18 months. On 14 October 2010, the Panel determined that it was necessary for the

protection of members of the public, in the public interest and in light of your conduct and behaviour, in your own interests, to suspend your registration. On 6 January 2011, the Panel determined that it was necessary for the protection of members of the public and the public interest, to replace the order of suspension with an order for interim conditions.

The Panel notes that there has been no significant change in circumstances relating to the issues that it has had to consider. It has considered the allegations that there may be elements of your website which breach the current conditions in place. However, on this occasion the Panel has determined to vary the interim conditions on your registration as follows:

- You must notify the GMC promptly of any post you accept for which registration with the GMC is required and provide the contact details of your employer and the PCT on whose Medical Performers List you are included, or the local Health Board/Health & Social Care Board if employed in Scotland, Wales or Northern Ireland.
- You must allow the GMC to exchange information with your employer or any contracting body for which you provide medical services.
- 3. You must inform the GMC of any formal disciplinary proceedings taken against you, from the date of this determination.
- 4. You must inform the GMC if you apply for medical employment outside the UK.
- You may only prescribe or advise the prescription of medication or treatment including repeat prescriptions when you have adequate knowledge of the

- patient's health and medical history to do so safely.
- 6. You may only prescribe or advise the prescription of medication for which a prescription is necessary, in accordance with the guidelines as laid down in the British National Formulary (BNF) and also National Institute of Clinical Excellence (NICE) guidelines where appropriate.
- 7. a. You shall maintain a log detailing every case where you personally prescribe, or advise the prescription of any medication by another doctor. This log should detail anonymised patient information, the date the patient was treated, the condition for which the patient was treated, and the name of the medication or treatment and the dose prescribed.
 - b. You must provide a copy of this log to the GMC prior to any review hearing of this Panel or, alternatively confirm that there have been no such cases.
- 8. You must continue to ensure in relation to your website, or any website relating to your medical practice, that there are no pages, downloadable content, including documents, forum or discussion board content, or other references or online media relating to the following subjects:
 - a. The medical management of cases relating to cardiology, or cardiovascular disease including chest pain due to ischemic heart disease; acute coronary syndrome; heart failure; or pulmonary embolus:
 - b. The treatment of asthma;
 - c. The treatment, testing, identification, diagnosis or management of breast cancer;
 - d. the use of hormonal contraceptive

medication:

- e. The pharmacological management of primary or secondary prevention of vascular disease;
- f. Any immunisation or vaccination.
- 9. You must inform the following parties that your registration is subject to the conditions, listed at 1 to 8, above:
 - a. Any organisation or person employing or contracting with you to undertake medical work
 - b. Any locum agency or out-of-hours service you are registered with or apply to be registered with (at the time of application)
 - c. In the case of locum appointments, your immediate line manager at your place of work (at least 24 hours before starting work)
 - d. Any prospective employer or contracting body (at the time of application)
 - e. The PCT on whose Medical Performers List you are included, or seeking inclusion (at the time of application), or the local Health Board/Health & Social Care Board if employed in Scotland, Wales or Northern Ireland
 - f. Your Regional Director of Public Health (England & Northern Ireland) / Health Board Director of Public Health (Scotland) / National Director of National Public Health Service (Wales).

The Panel has heard from Ms Bates that further complaints about your practise have been received since the date of your last hearing. However, you have drawn the Panel's attention to the apparent inconsistencies in the information provided. In the circumstances, the Panel has attached such weight to the allegations as it deemed appropriate.

The Panel has taken into account all of the documentation before it today, including full

transcripts from the previous hearings, the new information received since 10 January 2011 and the further documentation supplied by you. The Panel has also considered the submissions made by Ms Bates and those made by you.

In reaching its decision to vary the interim order of conditions, the Panel has taken into account the Rule 8 letter dated 2 March 2011. This letter outlines the background to your case, the Case Examiner's decision to refer it to a Fitness to Practise Panel and the particularised concerns and allegations made in reference to your Fitness to Practise.

The Panel notes that it is not its function to test the evidence or make a substantive decision regarding the allegations made against you. It is the judgment of this Panel that the allegations made against you, if substantiated, could indicate that your fitness to practise may be impaired. In all the circumstances, and having comprehensively reviewed your order today, the Panel is satisfied that it is necessary for the protection of members of the public and in the public interest, for your registration to be subject to an interim order of conditions as varied.

The Panel has taken account of the issue of proportionality in that it must act in a way which is fair and reasonable. Whilst it notes that its order restricts your ability to practise medicine, the Panel has determined that, given the nature of this case, imposing conditions on your registration, at this time, is a necessary and proportionate response to the risks posed by you practicing medicine unrestricted.

The order will be reviewed within four months, or earlier if necessary.

Notification of this decision will be served upon you in accordance with the Medical Act 1983, as amended."
