Usha Honeyman, N.D.,	CONSENT ORDER AND SETTLEMENT AGREEMENT

1.

The Board of Naturopathic Medicine (Board) is the state agency responsible for licensing, regulating, and disciplining naturopathic physicians in the State of Oregon, pursuant to Oregon Revised Statutes (ORS) chapter 685 and Oregon Administrative Rules (OAR) chapter 850. Dr. Usha Honeyman, N.D. (Licensee) is a licensed naturopathic physician in Oregon and is subject to the jurisdiction of the Board.

2.

The parties wish to resolve this matter informally, without any hearing, appeal or judicial review, by entering this Settlement Agreement and Consent Order, pursuant to ORS 183.417(3) on the terms set forth below. The Board finds, Licensee denies, but stipulates to the following:

3.

Licensee began treating Patient for Lyme disease in October of 2017. Licensee conducted a medical exam and completed a medical history for patient. Licensee conducted blood tests that indicated Patient had Lyme disease, and prescribed Patient Cefdinir and Minocycline.

4.

Patient had a history of reported heart issues and regularly sees a cardiologist. In 2019, Licensee prescribed Patient Azithromycin for a Bartonella infection without first conducting a cardiac

examination, and informed Patient that a known side effect is interference with the QT interval of the heart.

5.

Licensee prescribed Patient Azithromycin, with modifications based on the Patient's reports, from January 2019-June 2020. During this time, Patient reported seeking evaluation for chest pain and heart palpitations, but no cardiac problems were identified via her other providers and testing, and she was counseled on her anxiety. In 2020, due to COVID-19, Licensee transitioned her practice to telemedicine and did not examine Patient in person. Although Licensee inquired about the care, she did not obtain copies of the Patient's external records. Patient agreed to let Licensee speak to her cardiologist but did not provide the contact information.

6.

Based on the above conduct, Licensee denies, but the Board finds that Licensee's treatment of Patient violates ORS 685.110(8) and OAR 850-050-0010(1)(c)(B) for the following reasons: (1) not conducting a cardiac clinical exam prior to prescribing Azithromycin or during the following medical visits while the patient was taking Azithromycin; and (2) not requesting or reviewing medical records from any outside provider during the period of Azithromycin treatment.

### SETTLEMENT AGREEMENT

7.

The Board finds, and the Licensee denies the findings of facts and conclusions of law regarding the violations referenced in this settlement agreement and consent order. Licensee agrees that the Board may enter the Consent Order set forth below, including the following terms and conditions:

- A. Public Reprimand.
- B. Licensee enters into this Settlement Agreement and Consent Order voluntarily and without any force or duress. Licensee states that the Board and Board staff have not made promises or representations not stated herein to induce her to sign this document and agree to issuance of the Order.

- C. Licensee acknowledges that she had the opportunity to seek the advice of legal counsel.
  Licensee further acknowledges that she understands and agrees to the terms of this Order.
- D. Licensee understands that she has the right to a contested case hearing under the Administrative Procedures Act (ORS Chapter 183), and fully and finally waives any and all rights to a hearing and any rights to appeal or otherwise challenge this Settlement Agreement and Consent Order.
- E. The parties acknowledge that this Settlement Agreement and Consent Order is a public document.
- F. This Settlement Agreement and Consent Order shall take effect on the date it is signed by the Board.

Licensee.	OPPORTUNITY FOR HEARING

1.

The Board of Naturopathic Medicine (Board) is the State agency responsible for licensing, regulating, and disciplining naturopathic physicians in the State of Oregon, pursuant to Oregon Revised Statutes (ORS) chapter 685 and Oregon Administrative Rules (OAR) chapter 850. Dr. Usha Honeyman N.D. (Licensee) is a licensed naturopathic physician in Oregon and is subject to the jurisdiction of the Board.

2.

Pursuant to ORS 685.110(8) and OAR 850-050-0010(1)(c)(B) the Board hereby proposes to take disciplinary action against Licensee's license to practice naturopathic medicine, on the grounds described in the following paragraphs. For each violation, the Board may impose a civil penalty up to \$5,000, a term of probation, a letter of reprimand and license limitation, suspension, or revocation.

3.

Dr. Usha Honeyman has been a licensed naturopathic physician in the State of Oregon since September 25, 2008. Licensee began treating Lyme patients in 2009.

4.

Patient sought treatment from Licensee for Lyme disease in October of 2017. Licensee conducted a medical exam and completed a medical history for patient. Licensee conducted blood tests that indicated Patient had Lyme disease. Licensee prescribed Patient cefdinir and minocycline.

On or about January 24, 2019, Licensee prescribed Patient Azithromycin for a Bartonella infection. Licensee was aware, charted and advised Patient that a known side effect of Azithromycin is interference with the QT interval of the heart. Licensee was aware and charted that Patient has a history of heart issues and suffers from anxiety. Patient regularly sees a cardiologist and has an annual electrocardiogram. Licensee did not conduct a cardiac clinical exam on January 24, prior to prescribing Azithromycin.

6.

The QT interval is a measurement made on an electrocardiogram used to assess some of the electrical properties of the heart. It is calculated as the time from the start of the Q wave to the end of the T wave, and approximates to the time taken from when the cardiac ventricles start to contract to when they finish relaxing. The usual treatment for Bartonella is 1 month of azithromycin, followed by 6 months azithromycin plus rifampin.

7.

Licensee prescribed Patient Azithromycin from January 2019-August of 2020. Licensee was aware, charted and advised Patient that a known side effect of Azithromycin is interference with the QT interval of the heart. Licensee was aware and charted that Patient had a history of heart issues and suffers from anxiety. In Patient charts from their medical visits from January 2019-August 2020, Licensee charted Patient reporting chest and heart pain and heart palpitations, and Patient seeking care from urgent care and emergency room based on chest and heart pain and heart palpitations.

Based on these actions and information, Licensee's treatment of Patient violates ORS 685.110(8) and OAR 850-050-0010(1)(c)(B) for not conducting a cardiac clinical exam prior to prescribing Azithromycin or during the any of afore listed medial visits from January 2019- August 2020.

8.

Licensee prescribed Patient Azithromycin from January 2019-August of 2020. Licensee was aware, charted and advised Patient that a known side effect of Azithromycin is interference with the QT interval of the heart. Licensee was aware and charted that Patient had a history of heart issues and suffers from anxiety. In Patient charts from Patient medical visits from January 2019-

August 2020, Licensee charted Patient reporting chest and heart pain and heart palpitations, and Patient seeking care from urgent care and emergency room based on chest and heart pain and heart palpitations. Based on these actions and information, Licensee's treatment of Patient violates ORS 685.110(8) and OAR 850-050-0010(1)(c)(B) for not requesting or reviewing medical records from any outside provider during the period of treatment from January 2019-August 2020.

9.

Licensee prescribed Patient Azithromycin from January 2019-August of 2020. Licensee was aware, charted and advised Patient that a known side effect of Azithromycin is interference with the QT interval of the heart. Licensee was aware and charted that Patient had a history of heart issues and suffers from anxiety. In Patient charts from Patient medical visits from January 2019-August 2020, Licensee charted Patient reporting chest and heart pain and heart palpitations, and Patient seeking care from urgent care and emergency room based on chest and heart pain and heart palpitations.

Based on these actions and information, Licensee's treatment of Patient violates ORS 685.110(8) and OAR 850-050-0010(1)(c)(B) for not referring Patient to an outside provider to undergo a cardiac clinical exam during the period of treatment from January 2019- August 2020.

10.

For the violations described above; the Board proposes the following discipline:

- A. Probation 12 Months.
- B. Civil Penalty \$2,500
- C. Six (6) Hours of Pharmacology Continuing Education focus on drug monitoring, recognizing, and treating side effects, with emphasis on cardiac care, in addition to hours required for annual renewal per 850-040-0210, to be completed within the first six (6) months of probation.

## NOTICE OF OPPORTUNITY FOR HEARING

Licensee is entitled to a hearing as provided by the Administrative Procedures Act (ORS Chapter 183). If you want a hearing, you must file a written request for hearing with the Board within 21 days from the date this notice was mailed. You must submit request for hearing to either via

email Naturopathic.Medicine@obnm.Oregon.gov or U.S. Mail to Oregon Board of Naturopathic Medicine, 800 NE Oregon Street, Suite 407, Portland, OR 97232. The request for hearing must be received by the Board within 21 days from the date of mailing of this notice and must be accompanied by a written answer to the charges contained in this Notice. If a request for hearing is not received within 21 days, the right to hearing is waived.

12.

If you request a hearing, you will be notified of the time and place of the hearing. Before the hearing, you will receive information on the procedures, right of representation, and other rights of parties related to the conduct of the hearing. An administrative law judge from the Office of Administrative Hearings will preside at any hearing. ORS 183.635.

13.

An answer is required to this Notice, pursuant to OAR 850-001-0015, due to the complexity of the matters alleged above. The answer shall be made in writing to the Board and shall include an admission or denial of each factual matter alleged in this Notice, and a short plain statement of each relevant affirmative defense Licensee may have. Except for good cause, factual matters alleged in this notice and not denied in the answer shall be presumed admitted; failure to raise a particular defense in the answer will be considered a waiver of such defense; and new matters alleged in the answer (affirmative defenses) shall be presumed to be denied by the agency and evidence shall not be taken on any issue not raised in the Notice and answer.

14.

If you fail to request a hearing within 21 days, withdraw a request for a hearing, notify the Board or administrative law judge that you will not appear or fail to appear at a scheduled

hearing, the Board may issue a final order by default revoking your license. If the Board issues a default order, the contents of the Board's file automatically becomes part of the evidentiary record of this disciplinary action for the purpose of proving a prima facie case.
